

## NOTICE OF ORDER

#### **WILDLIFE AND COUNTRYSIDE ACT 1981**

# MODIFICATION ORDER NO.1 OF 2021 (FOOTPATH AT BLUE HOUSE LANE, PETERSTONE, WENTLOOGE).

Notice is hereby given that the above referenced Order has been submitted to the Welsh Ministers for determination. An Inspector will be appointed by the Welsh Ministers to determine the Order.

The start date for the above Order is 02/12/2022.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to add a public footpath at a width of 2 metres commencing at point A at a junction with the existing public highway known as St Peter's Crescent (grid ref. 326976E; 180184N) and proceeding in a north-easterly direction for a distance of approximately 390 meters to point B (grid ref. 327333E; 180339N), passing through a field gate and continuing in a north easterly direction for approximately 180 metres to Point C (GR 327507E; 180385N), then continuing in a southerly direction to Point D (GR327596E; 180211N) where it passes through another gate and joins public footpath 412/12.

### Timetable for sending in statements of case and comments

### Within 2 weeks of the start date [by 16/12/2022]

The Order Making Authority must ensure their statement of case is received by the Welsh Ministers. As soon as possible after the deadline, the Welsh Ministers will send a copy to everyone who has made an objection or representation, the applicant and any other person who has made a written representation.

#### Within 8 weeks of the start date [by 27/01/2023]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case (incorporating any comments on the Order Making Authority's 2 Week statement) is received by the Welsh Ministers. As soon as possible after the deadline, the Welsh Ministers will send copies to the Authority, the applicant, every other person who has made an objection or representation and any other person who has made a written representation.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Welsh Ministers. As soon as possible after the deadline, Welsh Ministers will send a copy to the Authority, everyone who has made an objection or representation and any other person who has made a written representation.

#### Within 14 weeks of the start date [by 10/03/2023]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has made a written representation must ensure that their comments on any or every other statement of case submitted at the 8 week stage (by any party other than the OMA) is received by the Welsh Ministers. As soon as possible after the deadline, the Welsh Ministers will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Welsh Ministers in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time.
